Your Leadership Mountain View (LMV) Program Acceptance Contract indicated that a source other than you or your employer would be needed to meet tuition costs. A limited number of financial assistance grants will be given to LMV applicants on a case by case basis, depending on available funds. Funding is provided by corporations, foundations and individuals in the community to ensure enrollment from a broad spectrum of individuals. Criteria for granting financial assistance are:

- * The applicant's contribution to ensuring a broad spectrum of community representation in the program.
- * The applicant's financial need.
- * The applicant's service to the community

A number of different options have been successfully used by past participants to provide the tuition for LMV, such as co-funding through your employer's Community Services Department or grants through organizations with which you may be affiliated (e.g. Rotary, United Way.) You can also choose to pay your tuition in monthly installments. As part of this financial aid application, we ask that you explore and exhaust those sources in honestly evaluating your level of need. Please complete the application as fully as possible, to assist the Financial Assistance Committee in considering your request. Financial Aid awards will be announced on Thursday, September 11, 2008.
